### 3 Sole-responsibility statement

This declaration of conformity is issued under the sole responsibility of the manufacturer. LPR Europe B.V. declares under its sole responsibility that the packaging described below complies with Regulation (EU) 2025/40 (PPWR).

### 4 Object of the declaration

#### Main material:

**Wood:** "P1" timber, as defined in the standard EN 12246 (1999), softwood species stemming from PEFC certified forests and/or PEFC controlled sources. LPR permits only the following species, for any component:

- Pinus Sylvestris (Scots Pine)
- Pinus Pinaster (Maritime Pine)
- Pinus Nigra Subs.Laricio (Black Pine)
- Albies Albaalbies Pectinata (Fir)
- Picea Excelsa / Picea Abies (Spruce)
- Pseudotsuga Menziesii / Douglasii (Douglas Fir)
- Larix Decidua (Larch)

**Nails:** non-alloy steel

#### Substances used on the pallet:

**Paint:** water-based paint from LPR's approved suppliers only.

**Anti-sapstain product:** Sinesto B or Antiblu Select 3787

**Type:** Reusable Transport packaging (closed loop pooling system)

**Food contact:** No

**Description:** The pallet is considered tertiary packaging, defined as packaging designed to facilitate the handling and transport of multiple sales units or grouped packages, while preventing damage during physical handling and transportation (as defined in the international standard EN 14182 (2003).

The pallet is intended for use within the LPR – La Palette Rouge controlled closed-loop pooling system.

Throughout the entire cycle, LPR retains ownership of the pallet.

Ready-to-use pallets are dispatched from an LPR Service Centre, filled with produce at customer sites, and then transported through retailer distribution centres to stores. Once emptied, the pallets are returned to an LPR Service Centre. The pallets are sorted out after each rotation (full service), inspected and repaired when required by LPR Service Centers according to LPR technical specifications.

The pallet is designed for repeated use across multiple rotations throughout its lifespan.

Pallets that are damaged beyond repair or have reached the end of their life are removed from circulation.

Pallets and wood waste coming from repairing and manufacturing activities are recoverable as either recycled material (animal litter, chipboards used for furniture, building...) or energy (wood pellets, woodchips used as fuel...).
